What is changing in Medicare for 2018?

2018 Part D Deductibles

Your Part D - Prescription Plan Deductible could be as high as \$405.

2018 Donut Hole or Coverage Gap - Part D Plan

Starts at \$\$3,750

You pay 35% of cost for Brand Names

You pay 44% of cost for Generics

You come out of the Donut Hole/Gap at \$7,508.75

2018 Extra Help Co-pays

For those who receive help from the government paying for their medications. [LIS, SLMB, QMB]

\$3.35 for Generics (\$3.30 in 2017)

MEDICARE HEALTH INSURANCE

Yes.....you are.

In April 2018 the Center for Medicare & Medicaid Services (CMS) will start mailing out the new Medicare cards. The cards will be mailed out in phases since there are approximately 60 million beneficiaries on Medicare. The process should be complete by December 31, 2019. You will not recognize the number on your new Medicare cards because it will no longer be your Social Security number. The new card will have a completely different and randomly assigned identifier that will be 11 characters long with a mix of numbers and uppercase letters.

You will not have to PAY to receive the new cards. It will be mailed to the address you have on file with Social Security. If someone tries to charge you for one.....it is a SCAM! Don't pay them! Please give us a call and let us know what happened.

Since it will take to the end of 2019 for everyone to receive their new cards. Both your current Medicare card and your new Medicare card will work until December 31, 2019. After that only the new number can be used to file Medicare claims. You will need to take your new card with you to all medical appointments to update your records.

If you or someone you know has Medicaid, QMB, SLMB, or QI1 ...and has moved or plan to move, you must change your address with the TennCare Office. The TennCare Office administers all of these programs. Failing to update your address with them could result in losing your benefits. Your local SHIP/SMP office can provide you with TennCare's Change of Address Form. Simply give us a call at (931) 379-2927.

Volunteers Needed!

The Ombudsman program is charged with advocating for the rights of residents who live in long term care settings such as nursing homes or assisted livings within our 13 county South Central District. Ombudsman visit facilities regularly to establish relationships with residents and facility staff. Ombudsman can help with a variety of issues residents may have whether the problem be simple or severe. The program is also a resource to families who are considering placement of their loved one in the long-term care setting. We provide information about facilities and are available for questions or concerns from families or residents anytime. Ombudsman also provide referral services to Legal Aid, Public Guardian program, APS, or other community resources as per the resident's request. The Ombudsman program is resident driven, resident directed and resident focused. In other words, we are an extension of the residents will and do our best to facilitate their wishes.

The Ombudsman program is constantly in need of **volunteers** to go to facilities and visit residents and report any issues they discover. Our volunteer training program is required of anyone who desires to participate in this program. The training consists of 2 days that cover the beginnings of the Ombudsman program, resident rights, how to advocate for residents, nursing home and assisted living rules and regulations, etc. etc. The next Ombudsman Volunteer training will be held after the first of the year and will be advertised over radio announcements, local newspaper articles and at area Senior Centers.
