Richard Stewart, CLEO asked everyone to go around the room and introduce themselves and state where they are located.

After all the introductions Richard Stewart, CLEO asked for nominations of officers for the board; Chair, 1st Vice-Chair, 2nd Vice-Chair, and Secretary/Treasurer at
